Help children impacted by lupus. This is especially rewarding - and challenging too. There is little being done for children diagnosed with lupus, but the LFA, GOC is making strides. We support a bi-monthly pediatric peer group with Nationwide Children's Hospital in Columbus. In 2018 we also worked with Cincinnati Children's Hospital to support Camp Joy in Clarksville and formed a Pediatric Lupus Coalition to help advocate for lupus patients needs and rights in the 2018 Lupus Advocacy Summit.

We held two statewide educational conferences. This resulted in us investing in technology upgrades and leaning on the staff to learn to use the new technologies swiftly and accurately.

Here at the Foundation took the position that we would want to support the stay-at-home efforts, and immediately switched all of programming to digital avenues.

This included monthly support groups across the state., Classes for the Newly Diagnosed Patients, Classes for Young Lupians, Physicians "Ask the Expert Series" that were presented monthly and we added a Prayer Group for those that lean on prayer.

To stay engaged and to build trust amongst those we serve we created other ways to stay connected. We started with the first ever digital Lupus Magazine. These went to over 5000 constituents in Ohio as to well over 300 print copies to physicians waiting rooms. We introduced our first ever Pod Cast "The Lupus Living Room" and "Lupus Night Light Blog.

We have added to our website a Resource Tool Kit not only for physicians but for caregivers and lupus patients. This is a constant breathing project. We are constantly adding and updating resources.

We are most proud that we trained over 30 Patient Navigators from across the state of Ohio. This ensures that there is a on the ground person that is training and is willing and able to assist the patients and their family if needed. These Navigators have quarterly training with the latest and most accurate information and updates there is about lupus. They assist
